#### Waiver of Liability

All potential artists in the Golden Gallery Art Show MUST sign this waiver form and turn it in to the show organizers with your Application Form and submission fee(s). Refusal to sign this form will prohibit you from participating in this event.

I hereby certify that I understand the artwork submission information and, to the best of my knowledge, this submission complies with all requested information and is wholly the work of the artist. Only artists displaying their original art will be able to participate in the Golden Gallery Art Show.

Golden Gallery Art Show Committee reserves the right to request removal of displayed work that does not reflect that which is submitted on the application form (i.e. crafts, other artists' work, etc.). Absolutely no imported, manufactured or mass-produced items, kits or articles not made in total by the artist. All decisions are made ultimately at the discretion of the Golden Gallery Art Show Committee without explanation. Once accepted into the show, all fees are non-refundable.

The Show Committee will not handle artwork sales. It is in the artist's responsibility to negotiate sales and matters of taxation. The Show Committee will not take any commission on artwork sold during the event. In the event of a sale, the artwork must remain displayed until the designated pickup date, no exceptions.

Artist grants permission for Show Committee to reproduce his/her name, information describing his/her work, representations (including photographs) of his/her work and any other information he/she has provided for the purpose of display, promotion and publicity – printed or electronic media – either now or in the future without compensation.

Artists are responsible for the transportation of artwork to and from the Union Colony Civic Center and at his/her own risk and expense. It is the artist's responsibility to pick up their artwork during the time specified. Neither the Show Committee nor the venue will be held liable for artwork not retrieved during scheduled pick up times. Artwork left over 30 days becomes the property of Catholic Charities Senior Program to sell with proceeds to benefit older adult clients in the Catholic Charities Senior Program.

Release of Liability: The City of Greeley, Union Colony Civic Center, and the Weld County Area Agency on Aging shall not be liable for any injury to Artist, their personnel, agents or employees or for any damage or loss of Artist's work, equipment or other personal property arising out of the Golden Gallery Art Show, the mounting and/or any other activities involved in the preparation, clean up and/or presentation of the Art Show. Artist agrees to assume all risk of damage to or loss of his/her own art from whatever cause.

Insurance: Artist shall be solely and exclusively responsible to insure properly and adequately their work and property.

Indemnification: Artist shall indemnify, save and hold harmless the City of Greeley, Union Colony Civic Center, and the Weld County Area Agency on Aging, its officers, directors, employees, volunteers and agents and the participating exhibition venues from any and all claims, demands, causes of action and judgments, losses, costs and expenses, including but not limited to reasonable attorney's fees, arising due to the negligence of Artist, their employees, agents or other personnel hereunder, including but not limited to any representation, warranty, term and/or condition of this Agreement. Additionally, nothing related to this Art show shall be construed or interpreted as a waiver, express or implied, of any of the immunities, rights, benefits, protections or other provisions, of the Colorado Governmental Immunity Act §§24-10-101 et seq., as applicable now or hereafter amended.
