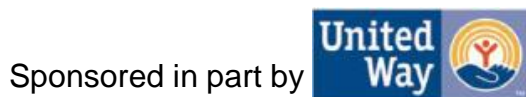

Qualification Process and Information:

1. Participants must be citizens of Greeley or Evans.
2. The ADA Assistance Program is for participants that may not qualify for Youth or Senior Assistance and fall under the ADA protection. If participant receives either Youth or Senior Assistance, they cannot in addition receive ADA assistance for that year.
3. Once qualification is confirmed, each Participant can utilize a \$150 scholarship toward registration costs for non-contracted programs offered through the Greeley Recreation Division.
4. The ADA Assistance Program **cannot** be used towards memberships, punch pass, or daily fees.
5. The ADA Assistance Program scholarship program will expire December 31st.
